#### General applicable conditions

The total amount of discounts under Art. 245.3 applied in the year 2023 of this Port Authority may not exceed 20 percent of the joint annual revenue collected from the vessel, passenger and cargo in the year 2022. In the event that the joint annual revenue collected from the vessel, passenger and merchandise rates in the 2021 financial year is lower than that of the year 2019, the latter will be taken.

The Port Authority must automatically suspend the application of these discounts once the maximum total amount for the year has been reached.

In no case will the discount exceed 40% of the quota of the rate itself (ship, merchandise or passenger) within each type of traffic or sensitive, priority or strategic maritime service.

The multiplicative effect of the compatible discounts may not exceed 40% of the discount on the quota of the corresponding rate.

Tranches not included: 0% discount.

TEU ("Twenty Equivalent Unit"): container unit equivalent to 20 feet.

UTI (Intermodal Transport Unit): goods road transport element (platform for containers, rigid or articulated vehicle, semi-trailer and trailer).

"Maritime transit", "Transshipment of Goods", "Maritime entry/exit", "Maritime service" and "Regular maritime service" according to definitions included in Annex II of the Consolidated Text of the State Ports and Merchant Marine Act.

These discounts will not be applicable in any case to the port traffic that uses facilities under an administrative concession system that, upon the entry into force of Act 48/2003, had opted for the application of the quotas of the rates of use foreseen for installations not under concession with the discounts provided for in their concessionary title.

#### Specific applicable conditions

a) The discount percentage of the section corresponding to the annual traffic reached is applied to all the units operated since the entry into force of this Act.

b) The discount percentage is applied differentiating in each section the units included in it from all the units operated since the entry into force of this Act, initiating the accounting of the goods from the beginning of the year.

c) If a certain type of maritime traffic or service meets the conditions to be a beneficiary of more than one of the sections defined in this table, they will be applied successively, multiplicatively, without exceeding 40% discount on the quota

of any one tariff (vessel or cargo) in the following order of prevalence:

1. Rail intermodality

2. Maritime arrival/departure and maritime transit, in maritime service

d) It will be applied at the end of the year once the traffic carried out has been justified and with the maximum discount according to the traffic achieved.

e) The discounts in this section will not be applicable to operations carried out at terminals with berthing concessions.

f) For each tariff code, the discount will only be applicable individually to the cargo expressly considered.

g) The discount and the sections to be considered will be applied individually to each of the tariff codes.
