WHAT DOES THIS ENVOLVE?

From 16th February 2015, anyone, wishing to access the Chemical or the Hydrocarbons quays, will have to raise the entry barrier with their authorized pass for accessing the port area. This control point will not be supervised, so the authorization pass must have been requested and processed prior to accessing the quays.



WHO WILL BE AFFECTED?

All companies and their staff members requiring access to the aforementioned quays in order to carry out their work activities with the exception of messenger services previously registered in the ISIS system and the taxi drivers who must adhere to other procedures.



Companies with staff members requiring legitimate access to the aforementioned quays must inform the Port Authority, through the Accreditation Center, so that the port access cards already in use, to allow access to the outside perimeter of the port area, can be updated.



WHO DO I NOTIFY?

The Port Authority in writing with proof of legitimate interest and delivered in person to the Port Authority General Register (Passeig de l'Escullera S/N) or by e-mail addressed to registro.sap@porttarragona.cat





Companies must demonstrate legitimate interest to access the aforementioned quays by means of a document accrediting a link with a resident company, ship suppliers (chandlers) or with a ship agent.

As a guideline, a company will be able to demonstrate legitimate interest by means of a service contract or responsible declaration of a professional evolvement with a resident company located in the aforementioned quays or with some other third party (ship suppliers/ship agents ...) providing services on a regular basis in the aforementioned quays.

On receipt of the necessary documentation the Port Authority will verify the claim and where appropriate update the existing passes to enable access to the given quays.



WILL THERE BE ANY POLICE PRESENCE THE ACCESSES TO THESE QUAYS?

No, the accesses are unattended.

The entry/exit barriers will open on detection of an authorized card providing the holder has been granted permission to access these zones.

DO YOU NEED TO

Please go to the Accreditation Center any working day from 7h to 19h (Castilla quay) to gain access to these zones on submission of documentation accrediting this requirement via; delivery order, delivery note from the carrier, etc...

Outside these hours, (non-working and public holidays and working nights from 19h to 7h) please go to the nearest police access point in order to gain entry to the quays. The West access point of the port is nearest (transverse axis access).
