General conditions of application

The total amount of the discounts under Art. 245.3 applied in the 2021 Port Authority financial year must not exceed 20 per cent of the annual joint revenue collected from that vessel, passage or merchandise taxes in the financial year 2019.

The Port Authority must automatically suspend the application of these discounts once the limit of the maximum total amount for the year has been reached.

In no case will the discount be greater than 40% of the quota of the same tariff (vessel, merchandise or passage) in each type of traffic or sensitive, priority or strategic maritime service.

The multiplicative effect of the compatible discounts may not exceed a 40% discount on the corresponding rate quota.

Tranches not covered: 0% discount.

TEU ("Twenty Equivalent Unit"): container unit equivalent to 20 feet.

UTI (Intermodal Transport Unit): element of wheeled goods transport (platform for containers, rigid or articulated vehicle, semi-trailer and trailer).

"Maritime transit", "Merchandise trans-shipment", "Maritime entry/departure", "Maritime service" and "Regular maritime service" according to definitions included in Annex II of the Consolidated Text of the Law on State Ports and the Merchant Marine.

These bonuses will not be applicable in any case to the port traffic that uses facilities under an administrative concession regime that, on the entry into force of Law 48/2003, would have opted for the application of the quotas of the rates of use provided for non-concessions with the discounts provided for in their granted concession.

Specific conditions of application

a) The percentage discount of the tranche corresponding to annual traffic achieved is applied to all units operated since the entry into force of the current act.

b) The discount percentage is applied, differentiating from each tranche to the units included in it to all units operated since the entry into force of the current Act, starting the accounting of the goods from the beginning of the year.

c) If a certain type of traffic or maritime service meets the conditions to benefit from more than one of the tranches defined in this table, they will be applied successively and multiplied and will not exceeding a 40% discount on the quota of the same tariff (vessel or merchandise) in the following order of prevalence:

1. Rail intermodality

2. Maritime entry/exit and maritime transit, in maritime service

d) It will be applied at the end of the year once the traffic carried out has been justified

e) The discounts in this tranche will not be applicable to operations carried out in terminals with berthing granted in concession.

f) The discount will be applicable as long as the stevedoring companies of these products carry out at least 70% of the annual calculation in a schedule of not less than 10 hours a day, from Monday to Friday on working days, without interruption.

g) For each tariff code, the discount will only be applicable individually to goods expressly considered "de forma expresa"

h) The discount and the tranches to be considered will be applied individually to each of the tariff codes.
